### Notice Concerning Reorganization of the Company's Consolidated Subsidiaries

In the meeting of the board of directors held today, the Company resolved to merge three consolidated subsidiaries in the East Japan area and three consolidated subsidiaries in the West Japan area on October 1, 2013 and reorganize them into a single company for each area as part of the management organization reforms in the NTT Network Engineering business of the MIRAIT Group.

Some disclosures have been omitted because the mergers are between consolidated subsidiaries of the Company.

#### 1. Purpose of the Merger

The MIRAIT Group reorganized its business last October to promote unified management of the Group.

The purpose of these mergers is to further improve productivity and improve efficiency by improving processes and optimizing personnel through the implementation of a reorganization of consolidated subsidiaries involved in NTT network engineering that overlap within the same regions because of the anticipated decline in demand for work related to optical fiber due to the maturing of the fixed broadband market.

Furthermore, an effort will be made to strengthen the business organization in the NTT network engineering business in the future through moves such as consolidating the design and implementation operations dispersed across each work base to be organized by function.

#### 2. Overview of the Reorganization

#### (1) Merger of the Three Companies in the East Japan Area

Daimei Next Co., Ltd., Todentsu Technos Corp. and Renat Tokyo Co., Ltd. will be merged with Daimei Next Co., Ltd. as the surviving company and the trade name being changed to "M's Frontier Co., Ltd.". (Scheduled for October 1, 2013)
